- xix. Thursday, November 23, 2023 at 8:00 a.m. Central Time and ends on Sunday, November 26, 2023 at 5:00 p.m. Central Time (Abu Dhabi); (each an "Entry Period" and collectively, the "Entry Periods")

**3. How to Enter:** During each Entry Period, there are two (2) ways you can earn entry into the Giveaway:

- a) Download the MoneyGram® App and complete the online submission form in the race Hub by providing the required information, including (i) your full legal name, (ii) email address, (iii) mobile phone number (iv) city and state of residence. All submissions will be entered into the random drawing subject to age and state of residence eligibility.

- b) Visit MoneyGram.com/HaasF1Team and complete the online submission form by providing the required information, including (i) your full legal name, (ii) email address, (iii) mobile phone number (iv) city and state of residence. All submissions will be entered into the random drawing subject to age and state of residence eligibility.

One entry per person permitted during each Entry Period. Duplicate entries for the same Entry Period will be rejected for entry in the Giveaway. All entries must be received and recorded by Sponsor during each Entry Period in order to qualify for the specific drawing. Sponsor's database clock will be the official timekeeper for entries in this Giveaway.

Except as otherwise contemplated in these Official Rules, Sponsor will use personal information collected in connection with the Giveaway in accordance with its [Privacy Statement](#).

5. **Prizes and Selection of Winners:** Giveaway participants who have completed the submission form and opted-in to MoneyGram Haas F1 Team updates and marketing by email and SMS will be automatically entered for the chance to win cash prizes per the following performance triggers OR per the surprise and delight trigger:

**Performance Triggers:**

- **Race Qualifying Triggers**
  - If team driver, Nico Hülkenberg, finishes in the Top 10 during qualifying, 50 potential winners will be randomly selected to each receive a \$100 cash.
  - If team driver, Kevin Magnussen, finishes in the Top 10 during qualifying, 50 potential winners will be randomly selected to each receive a \$100 cash.

- **Race Day Triggers**

- If team driver, Nico Hülkenberg finishes the race in the Top 10, 100 potential winners will be randomly selected to each received a \$200 cash.
- If team driver, Kevin Magnussen finishes the race in the Top 10, 100 potential winners will be randomly selected to each received a \$200 cash.

**OR**

- If team drivers, Nico Hülkenberg finishes the race in the Top 3, 20 potential winners will be randomly selected to each receive a \$1000 cash.
- If team drivers, Kevin Magnussen finishes the race in the Top 3, 20 potential winners will be randomly selected to each receive a \$1000 cash.

If one driver finishes Top 3 and one driver finishes Top 10, both prizes will be awarded with a maximum of \$40,000 in race day prizes. *Note: An individual racer's Top 3 finish negates the prize award for the Top 10 finish trigger.*

**Surprise and Delight Trigger:**

- If NONE of the above performance triggers occur, 200 potential winners will be randomly selected to each receive a \$50 cash.

Surprise and Delight Trigger will not occur if even ONE performance trigger listed above occurs.

Cash prizes will be distributed via one of the following MoneyGram receive options: (i) direct to bank account, (ii) direct to debit card, (iii) in-store cash pick up, (iv) send to phone, or alternatively, (v) check disbursement.

9. **General Conditions:** Sponsor reserves the right to cancel, replace, suspend and/or modify the Giveaway, or any part of it, for any reason including if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Giveaway, as determined by Sponsor in its sole discretion.
